DS-160: Online Nonimmigrant Visa Application. The DS-160, Online Nonimmigrant Visa Application form, is for temporary travel to the United States, and for K (fiancé (e)) visas. Form DS-160 is submitted electronically to the Department of State website via the Internet. Consular Officers use the information entered on the DS-160 to process the visa application and, combined with a personal interview, determine an applicant's eligibility for a nonimmigrant visa.

Application for Travel Document (Form I-131) can be used to apply for a re-entry permit, refugee travel document or advance parole travel document. Form I-131 should be submitted to U.S. Citizenship and Immigration Services and approved before overseas trip (including trip to Canada and Mexico).
